What is the P2P Foundation and its role in research?

Identity

The P2P Foundation is a non-profit organization, a "Stichting", founded in Amsterdam in 2007, under Dutch law. The local registered name is: Stichting Peer to Peer Alternatives, dossier nr: 34264847. It's legal address is Realengracht 196 - 1013AV Amsterdam, Netherlands.

The P2P Foundation is a knowledge commons and a global community of researchers and advocates that monitors the emergence of peer to peer dynamics in society, i.e. through peer production, governance, and property models that are characterized by open access, partipatory process of governance, and property formats that guarantee universal access. This is monitored in every field of human activity.

The P2P Foundation community consists of both academics and independent researchers, which collaborate on a number of funded research projects, such as those for the EU Commission. Objectives

- to study and create a comprehensive knowledge commons about peer to peer developments that can be used by the general public, business actors, and researchers
- to interconnect advocates, innovators, entrepreneurs and policy makers, as well as artists and cultural producers, by allowing them to enrich their own initiatives and business through a knowledge of what others are already doing
- to curate the best material appearing on these topics in the global internet, to the degree we can understand the languages; but with a focus on English as international language

- to create a pluralistic understanding through dialogue both within and outside our community of practice, by attempting a theoretical understanding that is continuously challenged by new facts and critiques
- to scale interesting projects by letting them use an active network of expertise as well as publishing and promoting their projects

Our work



The information ecology consists of a blog for the interpretation of current events and trends which according to Topsy is a top **2% globally** retweeted blog, published four times a day; a wiki with 16.000 entries that have been consulted **17 million times**; Google gives us 138.000 results, a Ning forum and several mailing lists for discussions: a network of bookmarks using Delicious and an interconnected set of social bookmarking sites carrying more than **50,000 tagged** information sources. The total interconnected reach of the P2P Foundation has been calculated at 2.000.000 in terms secondary of audience, during early 2010.

A community

The aims of the P2P Foundation is to act as a global community of researchers, focused on understanding the emerging impact of peer production, peer governance, and peer property. This includes associated phenomena such as open innovation, co-creation and co-design. crowd-sourcing and crowd-funding. Ωf particular interest is the intersection between the newly enabled 'horizontal' social processes. with the pre-existing, more 'vertically' oriented institutions, such corporations as and governments. The P2P Foundation covers all domains of social activity, combining different experts for different projects. In our research collection we have particularly focused on the sustainability of open practices, i.e. on open business models.

The P2P Foundation members are present in all the world. It has representatives in Europe, Asia, South America, North America and Africa.

The P2P Foundation also co-organized 7 academic conferences and the leading members are also very active in the global lecture circuit, creating teams of local sympathizers in at least 60 countries. Michel Bauwens, founder and referent of the organisation, visits about 15 different countries per year to provide talks and keynote conferences and connect with local audiences.
